

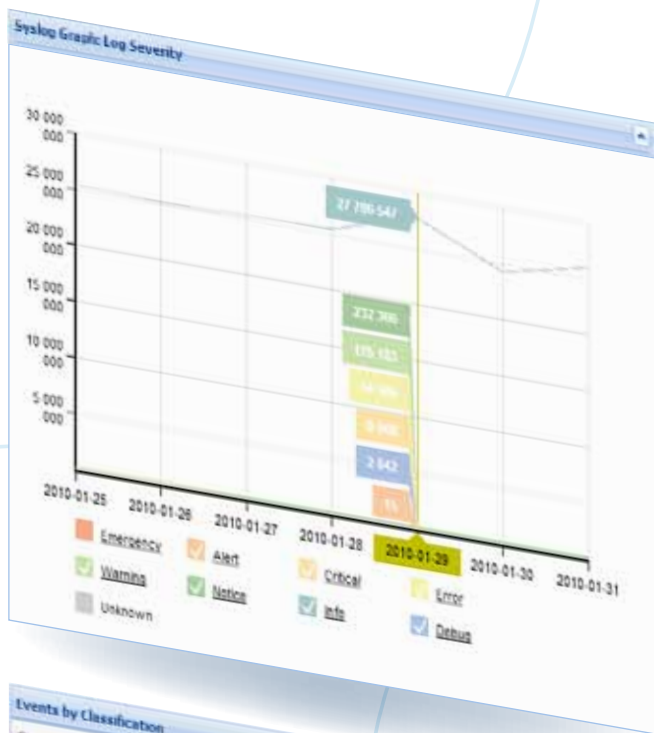

Implemented in LogInspect:

Risk Assesment

Confidentiality, Integrity, Availability (CIA). This well known model enable operational implementation of a calculated threat impact scoring – bringing focus on the most important events first

Dashboard – for ease of control

Advanced Dashboard technology – based on WEB 2.0 – allow the users to individually configure the Dashboards to reflect exactly the desired views depending on the users role in an organisation. The Dashboards display critical Events and Security Incidents real-time.

Event Correlation

LogInspect Event Correlation Engine can detect patterns of events, like multiple failed user account logins followed by a successful login from same user will trigger an “Attempted Bruteforce Login” event.

LogInspect Network Abnormally Detection Engine (NADE) can trigger an event on patterns detected in the network flow. E.g. detection of “Possible infected Spam Host” just by looking on the network communication behavior.

Active Respons Engine

Allow users to receive e-mail on detected security incidents. Allow for automatic system triggers on certain event i.e. blocking an IP in the Firewall or shutting down users if suspicious security incidents occur.

Open Rule Framework

The framework we are using to create rules is open for all users, this allows sharing and creating additional rules per requirement including signatures for Correlation, Log Signature or NADE. LogInspect comes with ImmuneSecurity Certified Signatures. New rules are automatically updated to LogInspect when available.

Reporting out-of-the box

Standard reporting templates for Compliance reports like PCI, SOX, DS-484, HIPPA and more are part of the standard version of LogInspect – this templates can be modified or created from scratch using an intuitive LogInspect Report Wizard.

System requirements

LogInspect is delivered as pre-configured appliances but can also run smoothly in VMware environments. The actual hardware configuration can be seized for each customer.

The Licensmodel

The software is licensed based on a yearly fee that include all new upgrades, patches, signature subscriptions as well as e-support via the ImmuneSecurity Ticket System.
